## 2021 GoYin for Life Promotion Terms and Conditions

<u>Overview:</u> During the Promotion Period, Preferred Customers and Independent Business Owners (IBOs) may receive 1 free bottle of GoYin with each consecutive autoship\* order of 100pv\*\* or more by fulfilling the Qualification Requirements set forth below during the Qualification Period.
